**A NOTE ON PARTICIPATION GRADE:** Students are required to come to class having read the material assigned for that day. Students will also be required to come to each class meeting during Section 2 with a TYPED question or comment for each of the two chapters assigned for that day. If you miss class, you are responsible for checking with another student for lecture notes and any announcements that may have been made regarding scheduling or assignments.
