Course Description

This course introduces students to the issue of ethics in public administration. The course focuses on understanding and applying the theories of ethics to the role of a public administrator.

Course Objectives

1. To acquire substantive knowledge and understanding of the theories of ethics, compromise, and integrity and their importance to the field of public administration.
2. To develop the ability to recognize and apply this understanding to relevant issues and situations facing public administrators in their daily operations.

Course Requirements

Lessons must be completed by each Wednesday by roughly midnight. Students are required to read all assigned readings, participate on the discussion board, and complete two writing assignments. Lessons provide summary points based on what the author is trying to emphasize in their writings, the key elements. These are not to be considered all-inclusive and the student is responsible to use these summary points in developing their understanding.
