### **Course Description**

- The ability to understand and develop outcome assessments
- The ability to work as a team in developing and delivering course materials
- The ability to work as an individual in developing and delivering course materials
- To gain experience and knowledge of the art and craft of teaching
- To learn how to be a more effective teacher
- The ability to be self-critical and how to evaluate personal teaching style
- The ability to articulate a well written teaching philosophy
