## Course Description:

This course is designed to offer students a knowledge and understanding of architecture styles, designs and choices of the built environment of the modern age. Students will view presentations in each class and participate in discussions about architectural styles and design. Students will have additional research assignments that will study architectural choices in more depth.

## Course Objectives:

Students will gain an understanding of architecture, architectural styles and details and how the built environment contributes to and explains human history. Students will also study the motivating forces and feelings behind architecture and how design is influenced. Students will research architects, styles and the context and learn to discuss and evaluate architecture.
